

MINUTES
Town of Crested Butte
Regular Town Council Meeting
Monday, November 17, 2025

Mayor Billick called the meeting to order at 7:25PM.

Council Members Present: Mayor Ian Billick, Anna Fenerty (outgoing Council member), Beth Goldstone, Gabi Prochaska, Mallika Magner, Kate Guibert (incoming Council member), Kent Cowherd (via Zoom), and John O'Neal (via Zoom)

After approval of the Consent Agenda, Kate Guibert was sworn in as a Council member, and Anna Fenerty vacated her seat. Fenerty voted for approval of the agenda and Consent Agenda, and Guibert voted on the motions, beginning with appointment of Mayor Pro Tem.

APPROVAL OF AGENDA

Fenerty moved and Prochaska seconded a motion to approve the agenda. A roll call vote was taken with all voting, "Yes." **Motion passed unanimously.**

Goldstone moved and Prochaska seconded a motion to appoint Kate Guibert to serve as Council member through the November 2nd, 2027, election. A roll call vote was taken with all voting, "Yes," which included Prochaska, Magner, Goldstone, Cowherd, O'Neal, and Billick. **Motion passed unanimously.**

Mayor Ian Billick and Council members newly appointed, including Beth Goldstone, John O'Neal, and Kate Guibert, took the oath of office and signed accordingly.

NEW BUSINESS

1) Appointment of Mayor Pro Tem.
